**N.B – APPLICATION FOR TRANSFER OF OWNERSHIP OF VEHICLE IF NOT MADE IN DUE TIME (LATE FINE)**

- 1) Rs. 100.00 if made within 30 days of expiry of prescribed period.
- 2) Rs. 200.00 if made within 31<sup>st</sup> day and 60<sup>th</sup> day of expiry of prescribed period.
- 3) Rs. 300.00 if made after 60<sup>th</sup> day of expiry of prescribed period.
- 4) If the vehicle is transferred to a person who resides in the same state where the vehicle is registered, the fact should be intimated to the R.A. within 14 days.
- 5) In the case of a vehicle, registered in other state, within 45 days.
